DEFINITIONS

- 1. *Canadiana Cabinets*, hereafter referred to as "The Manufacturer", is a manufacturer of wood cabinetry and furniture including kitchen cabinets.
- 2. *Canadiana Cabinets*TM is a proprietary trade name and is used by the manufacturer and independent dealers and distributors in the promotion and sale of its related products and services.
- 3. "Signed Prints" are defined to be a set of drawings or plans signed by the Purchaser to acknowledge their agreement with the design and layout of the products manufactured by the manufacturer.
- 4. "F.O.B. Plant" is defined as picked up by purchaser at the manufacturer's plant.
- 5. "Dealer and Distributor" are defined as independent businesses. They are not agents of the manufacturer, or of Canadiana Cabinets. They market, sell, install, and service products manufactured by the manufacturer under the Canadiana Cabinets name.
- 6. "Customer" is defined as the person or parties who use the products manufactured by the manufacturer.
- 7. "Purchaser" is defined as the person or parties, as stated on the Purchase Order, who may be the Dealer, Distributor or Customer.
- 8. "Purchase Order" is defined as the prescribed order form for "Canadiana" products included with the Sales Catalogue.
- 9. "Warranty" is defined as the product guarantee as defined in this Sales Catalogue provided by Canadiana Cabinets, and specifically excludes any other representation or warranties implied, verbal or otherwise suggested by anyone.



- 1. **CONDITIONS OF SALE** The sale, installation, and servicing of "Canadiana" products is the sole responsibility of the Dealer and Distributor. The manufacturer will not be liable for any agreements (implied, verbal, written, or otherwise) between the customer and the Dealer or Distributor. The Dealer or Distributor will not represent itself as an agent of the manufacturer.
- 2. **PRODUCT & PACKAGING CHANGES** Due to the manufacturer's continual product research and development, the right is reserved to make reasonable changes, of any kind, without notice, and to deliver revised designs or models of goods, unless this right is specifically waived by the manufacturer in writing.
- 3. **PRICING POLICY REGULAR CANADIANA PRODUCTS -** All prices shown are listed and subject to regular discounts unless otherwise indicated. Prices and specifications are subject to change without notice. All prices are F.O.B. our dock.
- 4. **PRICING POLICY SPECIAL AND/OR NON-STANDARD PRODUCTS Special and Non-standard Products not listed or covered in the Canadiana Price List require "Non-standard product quotations" from Canadiana Cabinets, and are subject to special pricing for each individual order. The decision to accept any order rests entirely with the manufacturer.**
 - If special or Non-standard Products cannot be briefly and simply described accurately, they must be accompanied by drawings or sketches and specifications.
 - The manufacturer assumes no liability and provides no warranty for Dealer or customer designed, engineered and finished items or assemblies.
 - The manufacturer reserves the right to not accept orders for special items which, in their opinion, are not suited to their manufacturing facilities or systems or which would not be in the best interests of the manufacturer to produce.
- 5. **DELIVERY** Shipments will be made by the manufacturer to a particular area at a given time. Shipments within our distribution area, around Ontario, will be made at a distribution area percentage of the net cost of the merchandise. For shipments to areas not serviced by regular delivery, the manufacturer may use common carrier. The dealer is responsible to provide adequate assistance with unloading and be able to verify with the driver that all items on the pink shipping documents have been received. Once the driver leaves the premises, we will not accept claims for undelivered goods that have been signed for. This does not affect our willingness to deal with goods that are in error or dealt with by a back order.
- 6. **DROP SHIPMENTS** For deliveries that are not to the Dealer or Distributor's regular place of business, there will be an additional drop shipment charge of \$125.00 net for each location, whether shipped by the manufacturer or common carrier.



- 7. SHIPPING DAMAGE- Merchandise must be inspected by the Dealer at the time of delivery, and:

 If delivered by the manufacturer: Damaged items should be reloaded onto the van and returned to the factory.

 If delivered by Common Carrier: Damaged items should be either refused or a damage claim, against the carrier, should be processed immediately. Note: Damages resulting from common carrier shipments must be processed between the Dealer or Distributor and the Common Carrier, not through the manufacturer.
- 8. **RETURN FOR CREDIT Must be Authorised Must be Prepaid.** No cabinets, counters, or materials may be returned for credit without the prior authorization of the manufacturer. RGA form must be submitted. All custom or installed cabinets approved for credit will be credited at 50% of net price originally invoiced.
- 9. **AUTHORIZED RETURNS FOR REWORK OR REPLACEMENT** Drivers will not pick up items for return without prior written authorization from the manufacturer. Please obtain a return authorization number from the order desk. *All returns must be well packaged*.
- 10. **COLOUR MATCHING** the manufacturer will colour match as closely as possible. Colour matches for new or replacement orders should be identified explicitly. Dealers and Distributors must send the factory a sample adjacent to the area receiving the new colour matched item(s), if requested. Colour matching of discontinued Canadiana the styles or finishes, if available, will have an extra factory finishing set-up charge of the total list price of the units to be matched in the same colour, with a \$50.00 minimum charge to apply.
- 11. **RUSH HANDLING CHARGES** All orders requiring rush shipping and having a net invoice cost of \$400.00 or less before HST will have a rush handling charge of \$30.00 net added to the invoice if shipped by bus, or \$18.00 net if shipped by any other means (please specify) not including freight. These orders will be shipped freight collect unless other instructions are given. You can avoid rush handling charges by specifying that shipment should be made with your next regular delivery. Most of these small orders are for mouldings, hardware, etc. and we urge all Dealers to carry and build some inventory of these common items.
- 12. **CHANGES AND CANCELLATION OF ORDERS** The elapsed time between receipt of an order and its entry into manufacturing is very short, therefore, order changes and cancellations can be very costly to the Dealer and to the customer. We make every effort to enter your order accurately, however mistakes can happen. **Please check your order and confirmation carefully.** Your original order should be accurate and changes should be avoided if at all possible. Once a confirmation is signed changes will be up to the discretion of the Production Manager, and a \$75.00 minimum net change-order charge will apply in addition to any costs for materials already ordered. Charges for cancellation of a confirmed order will be determined by the Production Manager.

- 13. **TERMS OF PAYMENT** All orders are C.O.D., unless credit has been established by our Credit Department, at which time our terms are to be determined on an individual basis.
- 14. **TAXES** HST is not included in any catalogue price.
- 15. **DISPLAY DISCOUNT** Display orders must fall within the "Standard Lead Time" for the appropriate product line to qualify for discount.
- 16. **PRODUCT WARRANTY** The manufacturer warrants to the original purchaser that the manufacture of its products is to be free from defects in materials and workmanship under normal household use and service

FOR A PERIOD OF FIVE YEARS... ...FOLLOWING THE DATE OF PURCHASE.

Any product or part covered by this 5 year limited warranty which, in the reasonable judgement of the manufacturer, proves to be defective, will be either replaced or repaired by THE MANUFACTURER through the Dealer or Distributor from whom the products were originally purchased. The manufacturer shall have the final decision as to whether repair or replacement is the proper remedy.

WARRANTY CONDITIONS - Purchasers wishing to make a claim under this warranty must notify the original Dealer or Distributor from whom they purchased the product. Proof of purchase shall be required before the claim is acknowledged. *The obligation of THE MANUFACTURER, under this warranty, is only limited to the repair or replacement of the defective product or part.* In the event that replacement is necessary, and an exact replacement is not available, one of similar type and equal quality will be supplied.

WARRANTY EXCLUSIONS - This warranty does not cover damages which result from: neglect, accidental or intentional damage, normal wear and tear, repairs or alterations not authorised by the manufacturer, exposure to extremes in temperature and/or humidity, flood, fire, Acts of God, or any other cause beyond human control, use for purposes other than that for which the product was manufactured, damages or injury caused during installation or by shipping and handling.

This warranty does not cover the fracture of painted finish due to movement and shrinkage of wood products.



WARRANTY EXCLUSIONS cont."-

This warranty does not cover nor apply to any item, product, part, or material not sold or manufactured by the manufacturer. Notwithstanding, the same may have been sold by the Dealer or Distributor.

For all products sold to a Dealer or Distributor, this warranty excludes labour, installation, servicing costs, overhead costs, and all other costs other than the cost to replace or repair the defective products manufactured by the manufacturer, delivered to the Dealer or Distributor.

LIMITS OF LIABILITY - the manufacturer's liability, under any of the aforesaid warranty, is limited to the cost to the manufacturer to rectify the defective work or material to a maximum aggregate limit of the wholesale purchase price to the dealer. The maximum aggregate limit will be reduced by the amount of any payments or costs previously made or incurred by the manufacturer under, or in respect of, the warranty. Save for the above liability, the manufacturer shall not be liable for any other costs, expenses, or damages of any kind whatsoever, whether direct, indirect, or consequential, and no matter howsoever caused, and the Purchaser, for good and valuable consideration, hereby remises, releases, and forever discharges the manufacturer of any and all other claims and demands of whatever nature.

NON-WAIVER - No action or failure to act by the manufacturer shall constitute a waiver of any present or future right, limitation, or defence afforded to the manufacturer under the Warranty provisions herein. Nor shall any such action or failure to act constitute an approval of, or acquiescence to, any present or future warranty claim.

ACCEPTANCE - The acceptance of the manufactured products or the submission of a claim hereunder by the Purchaser shall constitute the Purchaser's acceptance and agreement to be bound by the provisions of this Warranty.

WARRANTY TRANSFERABILITY - This warranty is with the original Purchaser and not transferable to any subsequent owner.



ORDER ENTRY POLICY - It has been our practice to use our confirmation copy for production. This means that both our order desk staff and the plant staff have had to interpret the plan. This was cumbersome and led to some confusion and error. We will now submit your original order as it is placed, with all detail provided, as the only information on the shop floor. The confirmation will be for pricing and delivery date only.

In order to serve you better, we ask for orders to be placed in the following format:

- 1. **All orders** to be emailed to orders@canadianacabinets.com. No telephone orders can be accepted. *Please do not call the factory direct.* While this may seem an easy fix for some minor problem, the logistical nightmare that ensues is very disruptive and costly.
- 2. A scale drawing showing windows, doors, appliance openings and clearly visable Canadiana codes is required. Computer generated plans are preferred. Elevations are helpful but not necessary. Orders not readable will be returned and this will cause unnecessary delays.
- 3. A completed and signed Canadiana order form, with all pertinent information.
- 4. Detailed drawings of all custom cabinets or modifications. We cannot enter an order for custom cabinets without a clearly marked full page detail. (Have quoted prior)
- 5. Completed panel order and filler forms if required. Remember to mark grain direction, finished ends, and edge tape requirements.
- 6. Any quotations issued to you for particular items must be included in your order.

Orders can be submitted 24 hours a day, via e-mail. Your order will be entered for pricing and emailed back to you for review. This is your only opportunity to check the accuracy and interpretation of your order. Please note that the signed confirmation starts the clock. It is important that you confirm your order promptly.

All signed confirmations will be processed and put into production within 48 hours. At this time a delivery date will be set based upon our posted lead times, plus any additional time required due to special finishes, etc. Shipping dates are based on confirmation date. If your confirmation is returned with many changes being required, we will require a final confirmation to confirm we have understood your requests.



ORDER ENTRY - All orders, once confirmed, will be scheduled as production space is available. Add lead time for specials as required.

Delivery of in-stock items, ordered on a rush service order form, will be scheduled following 3-4 production days, and rush service orders requiring doors or non-stock items will be scheduled for the week following 15 production days. It is important that you specify on the order how you would like your RSOs to be shipped.

Please note on your order form if you have an order that is required sooner than the standard lead time. We will check production and let you know when the earilest shipping time might be available for you. Please note that changes to the production calender are completely at the discretion of the plant manager.

SERVICE ORDERS - Delivery of non finished in-stock items (hinges slides etc.), ordered on a rush service order form, will be shipped within 3-4 production days from signed confirmation. Rush service orders requiring finished parts produced in house will be scheduled for the week following 10 production days from signed confirmation. Rush service orders requiring finished parts that are outsourced will be scheduled for shipment the week following 15 production days from signed confirmation.

Because of the time frame, and urgency of service orders, once a service order (***.44) is confirmed, it cannot be changed.

Service orders under \$400 before discount are subject to the following charges:

Finish set up for standard stained colours \$25.00 net Finish set up for standard painted colours \$50.00 net Finish set up for structured multi step finish \$75.00 net

It is important that you specify on the order how you would like your RSOs to be shipped.

WARRANTY WAIVER

While solid wood doors may appeal to our traditional ideas about quality and durability, when it comes to painted finishes CANADIANA CABINETS recommends using MDF Doors.

Solid wood is prone to swelling or contracting, caused by the environmental conditions, such as humidity on the cell structure of the wood. This results in solid panels shrinking and growing, from season to season, sometimes revealing unfinished panel edges on raised panel doors and drawer fronts. Additionally, because of this movement, the joints of the frame where end grain meets long grain become a problem. Wood expands and contracts across the grain but not in the length of the grain causing painted finishes to crack and chip off at the joints.

MDF on the other hand is much more stable. It has no grain and it stays virtually the same from summer to winter therefore overcoming the problems noted above with solid wood. Because of this innate nature of wood we are unable to warrant wood doors against their finish cracking and chipping at the joints or unfinished edges showing around the panel whereas MDF can be fully warranted.

For these reasons CANADIANA CABINETS recommends using MDF doors when a painted finish is required.

If you have a customer that insists on having a painted wood order, your order must be accompanied by this disclaimer.
